

A genuine barracks brick taken from one of the oldest buildings on the CMA campus is now available to alumni for \$25 plus postage (\$10 USPS in contiguous states).

The handsome brick carries a brass plate with the school name and the dates it contributed to the education of some of the finest scholars and leaders in today's world.



Proceeds from the sale of these bricks will go toward the CMA Museum Project presently underway to convert the old campus Guard House into a display area for school artifacts and memorabilia.

The meeting was called to order by President Bill Raiford. Don Kimbrell offered the Invocation followed by the Pledge of Allegiance led by John Bass.

Minutes from our last meeting were approved by the association as written.

Treasurer's report was given and approved by the association.

#### Old Business

Tax Exempt Status – Don Kimbrell reported that the Tax Exempt Form requesting tax exempt status for the association was ready to send out and we should receive it back in about 60 days.

#### Dues Report and Class Realignment

Bobby Bain reported that he was investigating the realignment of class groups which should help us to get people to remember. He added dues notices would go out the end of the month. He plans to meet with Alice Algood on the realignment also.

#### Museum Project

Woody Pettigrew started out by taking care of some old business as he reported on the brick from Black Hall that was presented

to Nancy Prickett Whitley. This was given to her by the association in memory of her father Major Prickett, long time resident of Black Hall and Instructor at CMA.

The Motion on whether to continue to pursue the CMA Guard House as a Museum for the association was discussed next. Woody started out with some background and what had been done by the committee. He noted that he believed that the cost to do the remodeling of the Guard House plus all other costs would add up to approximately \$175,000 as it was laid out in the letter that Woody sent to the entire CMAAA mailing list in February. He said a vote was taken at the March 07 to continue the project for the next 90 days to allow additional time for the fund raising effort to progress and then have the board make a final determination on continuing or terminating the project. This effort raised approximately \$35,000 before the June 30 meeting. This, coupled with the association's approximately \$40,000 remaining from the Memorial

Project, brought the total funds available for the museum project to approximately \$75,000. Woody said that he thought this amount was not enough to continue but he would go along with any decision the Board made.

The lease agreement was covered next. He said that he had a Lawyer review it and he suggested that we try to negotiate on the utilities cost where CA pays it and the association pays the school. There was also an escape clause noted that allowed both parties to terminate the agreement if needed and stipulating if Columbia Academy terminates the lease without cause it will reimburse the CMAAA on a pro-rated basis for the initial money spent restoring the building. Woody reported that a preservation specialist reviewed the property and presented a very favorable report. A question was asked at this point on whether the structure could be on the National Historical Register. This was discussed and an action was taken to see if CA had any information on this area. Woody then reported on the results of two cost estimates received on performing the restoration work (new roof, new ceiling on porch area, new ceiling inside the

guard house, repair work to the floor) at a total cost of approximately \$22,000. He had also obtained an estimate for liability insurance at the cost of \$174 a year.

At this point much discussion occurred on the pros and cons to pursuing or halting our present course of action. Jack Walker '45 argued that the city might turn the old court house into a museum once they built a new judicial center and this would be available to the association to use space as a museum for "free". However it was argued by both Becky Moon '76 and Alice Algood that this was far from a certain fact and if it did happen it would be another area we could use in addition to the Guard House. Ed Tuggle '67 asked with the monies we currently had in hand could we start the project. That was a possibility and could be looked at. Ron Nall '61 stated emphatically that his entire class (Class of '61) was totally against the Guard House Museum project and that when the motion was called he would vote that way. He believed that we could make this contract more attractive to the association and offered to have his lawyer review it for enhancements. Woody noted this and said that he would provide it to Ron to have it reviewed. Many side discussions occurred

and were heard by the board. The motion was finally called on whether to continue with the Guard House Museum Project or not. If the motion passed, the association would pursue the arrangement as laid out in the February letter and work to get a lease in place with Columbia Academy. If the motion failed, the project would be cancelled and all donations received would be returned and all pledges would be voided.

### Voice Vote Carries: 18 for - 11 against

(Documentation used in capturing the facts in these minutes is part of the permanent record of the association along with the Voice Vote for each board member in attendance at this specially called meeting.)

### New Business

President Bill Raiford said that Bricks from Black Hall were available for sale. If anyone was interested please contact him.

Grand Reunion for 2008 is now in the planning stages. Dates for the reunion are Thursday, July 31<sup>st</sup> through Saturday, the 2<sup>nd</sup> of August 2008. Plans are to have the Friday night Social at the Graymere Country Club and the Saturday night dinner at the Saturn Union Hall in Spring Hill. These plans were voted on by the board and the motion carried.

Wally Couch '62 asked if the association would consider having a one charge Lifetime Dues for our members. It was proposed that the cost of such a membership could be set at \$300. A motion was made by Wally and seconded by Ed Tuggle '67. The Motion carried.

A Motion was made to reimburse Woody Pettigrew '73 for the expenses he incurred with the mail out to the full association mailing list concerning the Guard House Museum Project. Woody thanked the board but stated that he did not want to be reimbursed.

It was mentioned that if you had any old annuals from CMA that the Maury County Archives would like to put together a group of Annuals from the beginning of CMA until it closed in 1979.

The Board was advised that we could possibly get some support for the Museum Project from the Maury County Historical Society. Woody Pettigrew will investigate this possibility and advise the Board at a future date.

President Raiford adjourned the meeting at 12:05 PM, 30 June 2007.

# Conversion of Guard House To Museum Moves Ahead

The CMA Alumni Association Board of Directors conducted a special meeting on Saturday, 30 June to review the status of the Guard House Museum Project and make a final determination on the project. After much debate concerning the cost of the project, the specifics of the lease we will establish with Columbia Academy, and the amount of funds that have been raised to date to support the project to date, the Board voted to proceed with the project with a goal of having the Museum ready for dedication at the August 2008 Reunion.

We still have a long way to go, both in terms of fund raising and the time it is going to take to get the project completed, but we are on a path now to realize a purpose stated in our Association's original By-laws...to establish a museum for the display and preservation of Columbia Military Academy artifacts and memorabilia.

We have final estimates on the renovation work and are working to finalize the lease arrangement, meeting with the Columbia Academy Board in September to sign the lease and begin work on renovating the Guard House. The CMAAA Museum Committee consisting of Mike Gilchrist, Becky Moon and Woody Pettigrew will continue to spearhead this project but will be glad to take any suggestions or help from anyone that can provide the time.

There are many aspects to this project and we welcome any and all help. If you have already made a donation or pledge to

the project, we thank you for that.

If you have not made a donation, or if you have made one but want to make another, we encourage you to do so by completing the form provided in the Bugle and submitting it.

Work is about to begin and we need the support of the Association to make this project a success. We will keep the Alumni As-

sociation membership apprised by providing updates in the quarterly Bugle.

The Maury Country Historical Society is aware of the project to convert the Guard House to a CMA Museum and made a \$2,000 donation to the Alumni Association to support the project. This donation not only provides financial assistance to the project but, just as importantly, it reflects the Society's interest in and support of the project. We will continue to work with the Society as we proceed with the project.




## **Hugh B. Whitaker, Class of '47**


## **Bryant M. "Pop" Allen, Class of '52**

Bryant Manning Allen, age 72, died Monday, January 30, 2006, at St. Dominic Jackson Memorial Hospital, Jackson MS.

Following graduation from CMA, Bryant attended Mississippi College and the University of Mississippi where he earned a business degree. After graduation he served in the Army G-2 Intelligence. He had always had an interest in art and in 1965 opened Bryant Galleries in Jackson. A year later he opened a New Orleans gallery in the French Quarter. During this time he also served as Education Director for the Art Association of Jackson.

He would give slide presentations at the Municipal Gallery and give talks at schools. Bryant grew his gallery business by traveling throughout the country and around the world in search of fine artists that he could introduce to collectors in Mis-

**Black Hall Marches Into History...**The remaining shell of old Black Hall, named after Cadet Robert Black, has been torn down after more than 100 years as a CMA landmark. Known originally as Barracks #5, the building housed a machine shop and heating plant for the old Arsenal prior to its use as a barracks. Robert Black was killed playing football for CMA in 1930. The building was renovated in 1938 following the same floor plan as Jackson Hall built in 1937. Bricks found recently on the porch of North Black have been decorated with a brass plate and are for sale by the Alumni Association for \$25 each plus postage.

Mississippi and to visitors to New Orleans. Over the years, he and his wife and co-owner, Doris Allen, traveled to such countries as France, Germany, Spain, Hungary, Italy, Haiti, Mexico and Canada.

Bryant's desire to discover new talent led him to artists as far away as Buenos Aires and Ukraine. At one time, there were five Bryant Galleries' locations: Jackson, New Orleans, Birmingham, Atlanta and Palm Beach. Other locations were Houston and Dallas, Texas.

Among the many artists who began their career with Bryant Galleries were Wyatt Waters, William Dunlap, George Thurmond, Rolland Golden and Donny Finley. Bryant had also represented such national and internationally noted artists as Alvar, Dean Mitchell, Leonardo Nierman, Alan Flattmann, Juan Medina, Ed Dwight and many others.

The New Orleans gallery he built is now the oldest and largest gallery in New Orleans and continues in operation in the historic French Quarter. Bryant loved animals and over the years he had a series of Bassett Hounds. Jackson residents knew Bryant for years as the man who drove to work with a blue and gold Macaw on his shoulder.

When not searching for new artists, Mr. Allen was an avid Ole Miss football fan. His other passion included cooking.

In addition to his wife, Bryant is survived by two sisters, Ros Haertlein of Fredricksburg, Texas and Jeane Ferrin of Austin, Texas; a nephew Albert Haertlein and nieces Alma Hartlein, Deeny Hartlein, Flavia Ferrin Gaskin, Beth Ferrin Williams and great

nephews Michael and Bryant Haertlein, who worked for a time at the Bryant Galleries of New Orleans. There are also several great nieces and nephews.
