### Agenda and Reports

Mr. Layton ('74), President of the Association, called the meeting to order at 10:00 A.M. The number in attendance met the requirement for a quorum and Mr. Layton welcomed the attendees to the Spring meeting of the Board. Mr. Layton opened the meeting by asking Mr. Bobbie Bain ('72) to lead the attendees in a prayer. It was noted that Mr. R.C. Smith ('44) had traveled the farthest distance to attend the meeting, coming from Maryland. Mr. Layton reported that correspondence received since the last meeting included thank you letters from the Army and Navy relief associations that the Alumni Association provided financial donations to as a result of the attacks on the United States on 11 September 2001.

Mr. Bryant (Columbia Academy Busi-

ness Manager) provided an update on the CMA Memorial, speaking on behalf of Academy President Dr. Thrasher who could not attend the meeting as planned. A total of \$45,000 has been donated to the CMA Memorial Fund, with 80 people providing the donations. Dr. Thrasher and Mr. Bryant recently met with the architect and contractor to determine the best way to accomplish the project with quality for a realistic, affordable price. The academy is planning to go ahead a start preparing the area by moving dirt and power lines as necessary to begin the project. Mr. Bryant indicated that it is time to set a deadline to determine if the project should move forward as a CMA memorial or as a Columbia Academy project. He believes that the project can be done in phases with the Clock Tower, the

most expensive portion, being the last part of the project. His estimate is that the park area, perimeter sidewalk, stage area and attribute monuments can be completed for about \$250,000. The two statue monuments representing the Cadet era and the Columbia Academy era will be an additional cost and the Clock Tower will be another estimated \$300,000. There was much discussion by board members concerning cost, project viability, alternative ways to establish a memorial, and ways to try to raise the funds to support the project.

The board established in the October 2001 meeting that Columbia Academy should lead the fund raising effort and that support of that effort should be on an individual basis. The position at that meeting was that the board should not take action in any way in regard to the effort. That remains the board position. Mr. Bryant closed the discussion by welcoming the Board Members to the school and encouraging them to proceed with the memorial project with the desire being to begin work on the project as soon as possible.

Mr. Pettigrew ('73) read the minutes from the 27 October 2001 Board meeting and requested that the minutes be accepted as presented. Separate motions to accept the minutes were made and seconded. The motions passed.

It was noted that Mr. Barthell Joseph's name had been removed from the Bugle as a member of the Advisory Board since the last meeting. While Mr. Joseph resigned from the Nominating Committee, he did not resign from the Advisory Board. The mistake in the Bugle was noted and will be corrected with the next edition.

Ms. Moon ('75) presented the Treasurer's Report. A Certificate of Deposit valued at \$30,950.83 is at the FIRSTAR Bank and the current checking account balance is \$21,334.87. A copy of the Bank Statement for the period ending 3/6/02 is attached to the minutes. Ms. Moon informed the members that the Association purchased a \$42.70 clock that was presented to Mrs. Grimes by the Association as part of a recognition ceremony for her by Columbia Academy. A motion was made and seconded to accept the Treasurer's Report. The motion passed.

Mr. Bill Raiford ('55) provided an update on the Bugle and the Web Site. He noted that the mailout for reservations to the reunion could include additional requests for occupation information that can

be included on the Web Site. He also addressed the possibility of establishing a PX portion on the Web Site where CMAAA memorabilia and gifts can be sold. He noted that some publications allow for advertisements and asked the board to discuss its desire to allow advertisements in the Bugle. After discussion, it was decided that the practice of providing informal advertisements could continue but that formal advertising should not be done. The plan is to prepare two Bugle issues for distribution prior to the Reunion, the first going out within the next month and the second one being distributed about a month before the reunion. It was noted that the next Bugle should contain the reunion reservation forms. Additionally, the Bugle will include a Biographical Information request form to help get occupational information for the Web Site.

Mr. Layton informed the Board that he appointed Mr. Winston Elston ('74) to chair the Hall of Honor Committee. Mr. Elston informed the board that he was reviewing and revising the procedures for nomination and selection to the Hall of Honor and that he is looking for individuals to put on the committee.

### **Old Business**

The Secretary asked about the status of the billing statement that was agreed to for mailout at the October 2001 meeting of the board. The decision was made to allow for the Reunion Reservation form to be utilized as this year's mailout. As part of the discussion, Mr. Hart ('62) asked if we should send a separate invoice if a good response is not received this year. Based on the response to the mailout, a decision will be made as to whether or not a formal mailout should be conducted. The idea of informing members of their dues status with each Bugle mailout was discussed with no final decision being made. The concern was noted that a mailout could cost approximately \$700 with the potential of only as much as \$150 being collected.

### **Certificates of Merit**

The Secretary reminded the Board of a previous decision to present Mr. John Thornton a Certificate at the 2002 reunion and asked if there were any other certificates that should be presented. Jack Walker ('45) suggested Louis Ellis ('44) for a certificate.

The Board agreed to present a certificate (posthumously) to Ed Hessel for his work with the CMAAA. Mr. Layton will

invite a family member of Mr. Hessel's to attend the General Membership meeting to accept the certificate. The Secretary will have the certificates made and ready for presentation at the 2002 Grand Reunion.

General Otis C. Lynn were mentioned as a possible candidate for induction in the Hall of Honor. Mr. Elston will work the issue as the Hall of Honor Committee Chairman.

### **Dues Are Paid in Advance**

Mr. Fricke ('39) asked about the procedure for paying dues seeking clarification on dues payment with reunion registration being payment in advance or payment to cover the previous two years. The answer was that the dues paid with reunion registration are paying in advance.

Mr. Little ('50) informed the Board about a thank you letter he received from Mrs. Muth for a picture he provided her from the last reunion. Mr. Layton noted the work that Mr. Little has done over the years capturing the reunions and board meetings in pictures and thanked him for the efforts he has expended.

### **Nonprofit Still Under Investigation**

Mr. Smith ('44) asked about the status of the association's nonprofit status. Mr. Layton stated that we are chartered as nonprofit but we do not yet have the IRS exempt status. That is an open item that Mr. Layton will continue to work.

Mr. Gilchrist noted that it is time for the association to provide its annual scholarship to a Columbia Academy graduate. This action is handled locally with the school providing a couple of names to the local board representatives for a determination on the scholarship. This has worked very well with truly worthy individuals receiving the scholarships.

### **New Business**

The board decided that it should make a decision, along with the general membership, on if the board wants to formally get behind the CMA Memorial project. The board decided to make the memorial a point of discussion with the general membership at the 2002 grand reunion since there will have to be a decision made at that time by Columbia Academy if it is to proceed with the project as a CMA Memorial.

### **Memorial Alternative Proposed**

Mr. Layton asked if the association wanted to donate its money to restore Academy Hall so we would have a facility for a Board Room. The idea is that a donation from the association to the restoration of

the building would result in Columbia Academy providing a dedicated room to the CMAAA in the building. Mr. Gilchrist will talk with the CA Board and get an understanding of the CA Board's intention for the building and their feeling toward such an activity.

**Scholarship Increased**

A motion was made and seconded to raise the annual scholarship provided to a Columbia Academy graduate to \$1000. It was noted that the original scholarship amount was \$500 and that it has been \$750 for the past two years. The board voted to approve the increase to \$1000, beginning with this year's scholarship.

**Flag Ceremony**

Mr. Little noted that the Flag Ceremony will be conducted again this year at the closing of the General Membership meeting. He asked that representatives from the Classes of 51, 52, and 53 work to develop the list of deceased graduates from those years. The same flag from the 2000 reunion will be used for this year's ceremony. Mr. Cecil asked that the board provide some type of compensation to the Bugler who will play taps as part of the ceremony. Mr. Layton, as Association President, agreed that compensation would be provided.

Mr. Layton informed the board that a group will meet immediately after the Board meeting to work on the 2002 Grand Reunion. The concern is that someone has to take charge of this year's reunion. The local graduates who have provided the bulk of the work in the past will not be available to provide as much support this year. Mr. Layton asked for, and received, the Board's permission to hire one person to help with local coordination as was done for the 2000 reunion. The board agreed to a salary of \$200 a month of three months for this effort. The board members discussed the base location for this year's reunion and agreed that the only local establishment that has the facilities to support the administration operations as well as the Friday night social is the Honors Restaurant and Convention Center (former Holiday Inn and Ramada Inn). The board agreed to that location.

Mr. Layton informed the members that the Fall Meeting of the Board will be conducted on Friday of the reunion weekend, at 3:00 at the Honor's Restaurant and Convention Center.

Mr. Layton adjourned the meeting at 1:10 p.m. and thanked the members for their attendance and support.


**A MESSAGE FROM THE PRESIDENT**
