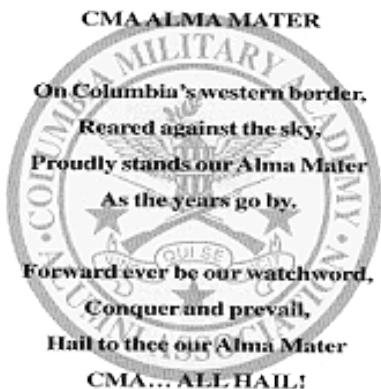

Sandra Gayle Jones Fly, 86, retired educator, and former longtime resident of Columbia, died Sunday, February 2, 2025, at Williamson Medical Center. Born August 22, 1938, in Jackson, TN, she was the daughter of the late Carvel H. Jones and the late Sue Nell Pirtle Jones. Mrs. Fly earned her Associate's degree from Columbia State Community College, went on to receive her Bachelor's degree from UT Nashville, and then obtained her Master's degree from Middle Tennessee State University. On December 23, 1956, she married Richard Wayne Fly, who preceded her in death on March 12, 2019. She worked as secretary for Columbia Military Academy from 1958 till 1972 and then taught at Highland Park Elementary from 1972 till 2002. Mrs. Fly was a member of First United Methodist Church. She is survived by her sons, Mark Wayne (Mary Lynn) Fly and John Richard (Julie) Fly; and four grandchildren. In addition to her husband and parents, she was preceded in death by a brother, John C. Jones.

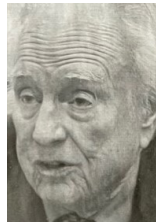

also pioneered the American use of Belgian deterrent technology to keep predatory and dangerous birds away from farms and airports-an enterprise he brought to the United States after reading about the business in Belgium and then flying to Europe to buy the company. In 1957 he married Julia Brooks, known as Judy, a native of Nashville and the child of a prominent Belle Meade family. Longtime chairman of the Mississippi Republican Party and informal power broker whose reach extended to the highest levels, Clarke was an important political force in the years of Richard Nixon, Gerald Ford, Ronald Reagan, George H.W. Bush, and George W. Bush. He hired college students who became governors and United States senators; he helped change the course of at least one presidential campaign, stopping Ronald Reagan's momentum against President Ford at the 1976 GOP convention. Clark and Judy had three children: the writer Julia Evans Reed (1960-2020); Reynolds Crews Reed (1968-2019); and Clarke Thomas Reed, Jr., who, with Mrs. Reed, survives him. He is also survived by granddaughters Brooks Henke (Bryan) and Evans Reed; nephew Brooks Corzine (Frannie); and two great grandchildren.

Clarke T. Reed, Class of '46

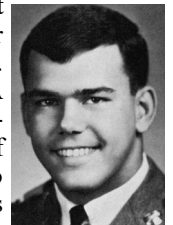
Clarke T. Reed-businessman, Mississippi civic leader, and a key architect of post-World War II Southern politics-died on December 8, 2024, at his home in Greenville, Mississippi. He was 96. Born in Alliance, Ohio on August 4, 1928, Clarke Thomas Reed was the son of Lyman and Kathryn Reynolds Reed. Raised in Caruthersville, Missouri, from the age of six months, Clake was educated in local public schools before attending CMA, graduating in 1946. Fascinated by flight-one of his great regrets was being too young to fly combat missions in World War II-he joined the Air Force ROTC at the University of Missouri, where he earned a degree in economics in 1950. He moved to Greenville, in the Mississippi Delta, where he became, in the words of The New York Times, "one of the ablest businessmen in the South." With a CMA classmate, Barthell Joseph, he founded the firm of Reed-Joseph International, an innovative agricultural equipment business that

Walker McGinnis, 77, of Huntsville, Alabama, died peacefully Wednesday, December 11, 2024, at the Hospice Care Center at Redstone Village. Walker attended CMA for three years, graduating with the Class of 1965. Walker went on to graduate from Rhodes College. A beloved educator, coach, and community leader, Walker dedicated over 40 years of his life to serving the students and families of Huntsville City Schools. Throughout his career, he held various roles including Principal of Chapman Middle School, Assistant Principal at Whitesburg Middle School and Grissom High School, and a coach who inspired countless young athletes. His unwavering commitment to education and leadership left an indelible mark on the community. He was known for his kindness, integrity, and dedica-

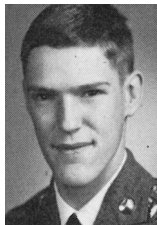

tion to his students, who held him in the highest regard. In 2014, Walker was elected to the Huntsville School Board and served 7 years representing District 4. He was also a national speaker on Special Education and regulations, and in 1998, he compiled the Huntsville City Schools Section 504 Resource Guide. Walker was honored as the 2006 Outstanding Administrator by the Alabama Association of Foreign Language Teachers. He had a deep love for his country and cherished his time in the U.S. Army Reserves, achieving the rank of Major. Walker was preceded in death by his father, Colonel Eugene McGinnis, and his mother, Lillian Hood McGinnis. He is survived by his loving wife, Jeaneen Brown McGinnis; his son, Walker (Jay) McGinnis, and daughter-in-law, Mikelyn McGinnis; his daughter, Donessa Gattis, and son-in-law, Clayton Gattis; his sister, Elizabeth Deckert; and nephew, Kevin Deckert. He was also deeply cherished by his four grandchildren who brought him immense joy.

Joseph A Syler, Class of '65

Joseph A. Syler, Sr., age 76, passed away on February 11, 2024. He was born August 18, 1947 in Detroit, Michigan, the beloved son of the late Mary and George Syler. He attended CMA for one year as a member of the Class of 1965. Joseph married his beloved wife Loretta on April 17,

1982. Joseph's passions included rooting for University of Michigan football and all Detroit sports teams. He took pride in his southern heritage, was a huge fan of classic country music as well as Bluegrass. He was an enthusiastic member of the N-SSA (North-South Skirmish Association) for nearly 40 years, founding the 14th Tennessee Infantry in 1974. Later he would become a member of the 6th Wisconsin Infantry, and the 1st Michigan Infantry. Reading and studying Civil War history was one of his favorite things. He had a deep love for his dog, Bogey and his grand-dogs. Many summers were spent at the family cottage in Caseville, where he loved being on the beach surrounded by family. He was a member of Scenic Country Club where playing golf brought him great joy. Joseph dedicated

over 30 years of his life to Valenite Corporation before finding fulfillment in his retirement as a Utica Community Schools bus driver, a job he truly adored. He also found solace in bird-watching and feeding birds in his yard. .

Jack P. Morgan, Class of '70

Jack Peirpoint Morgan Jr., age 72, passed away at his home on January 21, 2025. Jack was born on September 22, 1952, in Columbia, Tennessee, the third child of the late Jack and Martha Hill Morgan. He attended CMA for four years, graduating with the Class of 1970. After

graduation, he joined the U.S. Navy. He served his country for six years. During his time in the Navy, he was able to study electronics, radar, and electricity. These skills were the foundation of his lifelong career as an electrician. He was employed in the family business, Morgan Brothers Electric. He left for a time and worked at Nissan in Smyrna, Tennessee. He returned to Columbia and worked for a time at Morgan Brothers. He later became an independent electrician. Jack was a believer in Jesus and often had conversations about Him with his siblings and others. Jack had a generous, kind heart, and often tried to help those less fortunate than he. Survivors include Jack's two daughters, Amber (Ryan) Marx and Katie (Jordan) Gibby, and two grandchildren. He is also survived by his sister, Lynn (Donald) Steinfeldt and brother Bob (Elizabeth) Morgan, seven nieces and one nephew. He had three great nieces and four great nieces in law and ten great nephews. Jack had many cousins, some he knew well, and some he never met.

F. Willard Morris, Class of '71

Forest Willard Morris, Jr., 73, of Iuka, Mississippi, died on Sunday, February 18, 2024, at Tishomingo Community Living Center. Willard was of the Baptist faith and enjoyed going to services when he was able. Willard attended CMA for two years as a member of the Class of 1971. As a teenager, he began working as a butcher, and over time, he became one

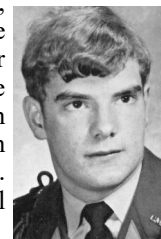

of the most well-known meat-cutters in Tishomingo County. Outside of his butcher job, he was also a master carpenter. He loved woodworking and found joy in building things for his family and friends. He was also a talented cook and grilled the best burgers. Willard is survived by his children, Sabrina Austin (Chris) and John Morris (Melanie); five grandchildren; four great-grandchildren; three nieces; and one nephew. He was preceded in death by his parents, Dora and Forest W. Morris, Sr.; and his sister, Elizabeth Jones (Connie Ray).

Howard Whitaker, Class of '71

The Rev. Dr. Howard W. (Doc) Whitaker died on January 27th 2025 at the age of 71. Born in Jackson, Mississippi in 1953, the son of a surgeon father and public health nurse mother, Howard Wilson Whitaker, III, grew up in Savannah, Tennessee. Starting in Junior School in 1966, he attended



CMA for five years **"Doc" Whitaker** graduating with the Class of 1971. He raised eyebrows and rolled eyes with an "Open Letter to Fellow CMA Alumni" in the Summer 2022 *Bugle*. He was proud of his time "behind the iron fence," but admitted the lessons he learned were far from those expected. After CMA, he was educated at American University, Episcopal Theological Seminary in Kentucky, and Wesley Theological Seminary. He was the author of *A Pastoral Commentary on Dissociative Disorders*, as well as articles, letters, reviews, and sermons in professional publications. Doc's career included stints as a photo journalist, police officer, mechanic, pastor, therapist, truck driver, hospital administrator, bookseller, beekeeper, and serial entrepreneur. His first job out of college was in the Baltimore City Police Department. He lasted two years. The experience rattled him so thoroughly that he operated a garage and wrecker service in the mountains of Western North Carolina for the next seven years. He married, had children, and could have led a quiet, redeemed life. But God draws straight with crooked lines. He migrated back to church in his 30s, being ordained as an Episcopal priest in 1988. He was an early Direc-

tor of St. Timothy's Farm & Mission, Barnes Mountain, KY, and served on diocesan staff for the Bishop of Lexington. He worked with Southern Empowerment Project and Appalachian Peoples' Service Organization. He emerged in 1994 as Director of Clinical Pastoral Services in Chattanooga, TN, providing trauma care for individuals and families, as well as clinical interim ministry for congregations. He taught the required parenting courses for Georgia's Lookout Mountain Judicial Circuit for 16 years. With Georgia Homestead, he helped develop that state's first in-home therapy to families in imminent danger of losing custody of minor children. He arrived in New Jersey in 2001 with the American Red Cross following the World Trade Center attacks, serving rotations as Chief Chaplain for the New Jersey Family Assistance Center at Liberty Park. After a sabbatical as an over the road truck driver, he returned to New Jersey and served eight years as Director of Pastoral Services at Greystone Park (State) Psychiatric Hospital. After leaving Greystone, he continued to commute north, doing clinical interventions in churches in the mid-Atlantic region for another decade. In retirement, he grew quieter. From his Scottsboro, Alabama office, he continued to see a few clients, kept a commercial apiary, and operated a used bookstore. He enjoyed his local anonymity. When prying minds inquired of Mz. Kay, "What does he do?" she would slyly reply, "He brings me coffee in the morning." Occasionally, he would deploy as a towboat chaplain for Seamen's Church Institute working inland waterways as far as Joliet and Mobile, typically for deaths and

traumas. He is survived by his wife and business partner, Kay Elaine Hamrick (Mz. Kay); two children from his first marriage, Ben Whitaker and Eva Whitaker, and their mother, Rosalie Smith Whitaker; a sister, Cheryl Whitaker McFarland; grandchildren; and a host of former clients, patients, and parishioners.
